**Enclosed is a RATE CHANGE for the existing exception tariff, Tristate 54, Effective May 11<sup>th</sup>, 2026 for BNT Movers, LLC (PA PUC Certificate #A-00122066) in Jefferson Township PA.**

The attached pages are 762<sup>nd</sup> Revised Page 2, 243<sup>rd</sup> Revised Page 2-B, 117<sup>th</sup> Revised Page 5-A, 4<sup>th</sup> Revised Page 21-A and Original Page 21-A-1.

This filing is for a **CHANGE** in the verbiage allowing the exception rates noted to pertain to shipments transported between points in Pennsylvania as this carrier was granted statewide operating authority in May 2015. It is also a request for an **INCREASE** in local hourly rates for shipments transported 40 miles or less, an **INCREASE** in container charges, and an **INCREASE** in the hourly rate per packer for packing/unpacking services.


