This letter serves as formal notification that New River Group, LLC d/b/a Scioto Energy will no longer be servicing customers in the Commonwealth of Pennsylvania and hereby request withdrawal of its electric generation supplier license effective April 1, 2026.

New River Group, LLC d/b/a Scioto Energy was acquired by Environ Energy, LLC, with the transaction effective 10/25/2025. As a result of this acquisition, New River Group, LLC d/b/a Scioto Energy is discontinuing its competitive electric brokerage/marketing activities in Pennsylvania.


