
Aqua Pennsylvania, Inc. (“Aqua”), by and through its counsel, is filing this Answer to Conneaut Lake Park Water Corporation, Inc.’s (“CLPWC”) Motion to Amend Prehearing Order No.5 (“Motion”) in accordance with Pennsylvania Public Utility Commission (“PaPUC”) regulations at 52 Pa Code §103(c) and in connection therewith represents as follows:

1. Aqua is an active party in this proceeding.
2. In the Motion, CLPWC requests a modification to Prehearing Order No. 5, which directed that the evidentiary hearings in this proceeding scheduled for May 4 and 5, 2026 be conducted in person in Harrisburg, Pennsylvania – not telephonically or via video conferencing.
3. CLPWC requests that certain of its witnesses located in northwest Pennsylvania – an approximate drive of 4 to 4 ½ drive from Harrisburg – be excused from attending the evidentiary hearings in person and be allowed instead to participate by video.
4. Aqua does not object to CLPWC’s witnesses participating in the evidentiary hearings via telephone, video conferencing or other technology in lieu of attending the evidentiary hearings in person.

WHEREFORE, for the foregoing reasons, Aqua does not oppose the relief requested in the Motion and allow certain of CLPWC's witnesses to participate in the scheduled May 4 and 5, 2026 evidentiary hearings via telephone, video conferencing or other technology.
