(a)(1) What is your alleged right or interest in filing this Protest?

My wife Cheryl and I own 40 acres in Dunkard Township, PA along Dunkard Creek and adjacent to the Longview property previously used to convey coal from the Dana 4 West mine to Longview Power Plant in Fort Martin, WV. Our neighbor is having a solar farm installed on her property. The exact route for transmission lines from that property could not be determined from the application.

(a)(2) State your grounds for filing this Protest.

I don't know if our property will be directly affected by the MARL, but I feel that in the long run the project will benefit corporations in Virginia with little to no positive impact on Greene County. The project could possibly have a negative impact on the region in the form of power outages and higher energy costs just to fill the Greed Coffers of corporate pirates that pillage poorer communities, especially since the "environmentalists" in Virginia have decided to decommission their coal-fired power plants for political correctness, so now they can steal power for their data farms from "bumpkins" and pretend that they aren't contributing to "Global Warming".
