**ORDER
CLOSING THE RECORD**

On January 20, 2026, Midtown Home Health Care LLC (“Applicant”) filed an Application with the Pennsylvania Public Utility Commission (“Commission”) seeking authority to transport, as a common carrier, by motor vehicle, persons in Paratransit Service, from points in the Counties of Bucks, Delaware and Montgomery, and the City and County of Philadelphia, to points in Pennsylvania, and return.

On February 7, 2026, the Application was published in the Pennsylvania Bulletin, with a protest deadline of February 23, 2026.

On February 23, 2026, a Joint Protest against the Application was filed by Bucks County Transport, Inc., Bux-Mont Transportation, Inc., Easton Coach Company, Suburban Transit Network, and Tri County Transit Service.

An evidentiary hearing for this case was scheduled for April 23, 2026.

On March 4, 2026, the Commission issued my Order directing the Applicant to have an attorney enter his or her appearance on its behalf on or before April 10, 2026. An attorney did not enter his or her appearance on or before April 10, 2026. As the Applicant did

not comply with the March 4, 2026, order, the scheduled evidentiary hearing will be cancelled, and the record will be closed via this Order.

THEREFORE,

IT IS ORDERED:

1. That the record in the matter of the Application of Midtown Home Health Care LLC, Docket No. A-2026-3059960 is closed.

2. That an Initial Decision in the matter of the Application of Midtown Home Health Care LLC, Docket No. A-2026-3059960 will be prepared and issued.
