Request for Information

- 1) The responses to questions 5(a), 5(b), 5(c), 5(d) and 5(e) of the verified statements are insufficient. Title 52 Pa. Code § 29 provides detailed requirements. Please provide a system which incorporates code specified compliance requirements, in particular regarding the frequency and retention of driver records. Each of your answers to sections of this question were insufficient:

- § 29.503. Age restrictions.
- § 29.504. Driver history
- § 29.505. Criminal history.

Even if you intend to be the only driver, you must have a code specified plan in place. Please find the required answers in Title 52, you can google to find them.

- 2) Your answer to question 8 on the Verified Statements, regarding whether or not you have taken steps to research the cost for Paratransit insurance was insufficient. Have you obtained quotes so that you are aware of the cost of said insurance for the services you intend to provide?
- 3) Your Statement of Financial Position shows funds that are insufficient to run a transportation business, with loans outstanding to be paid. Do you have additional access to funds for day to day expenses, insurance premiums, and necessary repairs if need to be able to provide safe, reliable and efficient services? It has been noted that your vehicle is 10 years old with 250,000 miles traveled.
