**INTERIM ORDER
CONTINUING TO STAY MATTER AND
DIRECTING PARTIES TO SUBMIT STATUS REPORT**

On August 18, 2021, I issued an Interim Order staying the above-captioned matter and granting a Joint Motion to transfer the matter to the Court of Common Pleas of Westmoreland County, Pennsylvania.

I have been in contact with counsel for both parties periodically since then by email, seeking updates regarding this matter.

On March 6, 2026, I deemed it necessary for the parties to file a status report regarding this matter as it had been quite some time since the matter was transferred. I issued an Interim Order directing the parties to file a status report as to the status of the matter and advise whether the parties believed the matter before the Commission at Docket No. C-2020-3021730 should remain stayed or whether it should be closed.

On April 3, 2026, the parties filed a status report, advising the matter was still pending before the Court of Common Pleas of Westmoreland County and requesting that the matter remain stayed.

THEREFORE,

IT IS ORDERED:

1. That the matter at Stephen Morgan and Brian Dolfi v. Columbia Gas of Pennsylvania, Inc., at Docket No. C-2020-3021730 remain stayed.
2. That the parties shall file a status report within thirty (30) days of the resolution of the matter pending before the Court of Common Pleas of Westmoreland County.
