## RULES & REGULATIONS

1. Advance reservations are required and must be made twenty-four (24) hours before service is to be rendered.
2. Hourly rates commence at the time the vehicle leaves the garage until the vehicle returns to the garage.
3. Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours of continuous drive time will be added to the basic charge.
4. Gratuity: A gratuity of 20 % shall be added to all of the carrier's charges.
5. Promotional Fares / Discounts: Upon presentation of an advertised coupon or other special promotional offer, carrier will offer rates at a specified discount from the published tariff rates on the dates authorized by the coupon or offer. Advertised coupons or other special offers will be filed with the PA Public Utility Commission prior to publication or broadcast in one or more of the following: local newspapers, radio and television advertising, flyers, postcards, or other printed media.
6. Deposits: All reservations require a deposit of not more than 20% of the quoted charter price.
  - a. Deposits are subject to forfeiture of not more than 50% of the deposit if the charter is cancelled by the customer more than 15 but less than 30 days prior to the date the transportation was to depart.
  - b. Deposits are subject to forfeiture of not more than the total amount of the deposit if the cancellation occurs within 15 days prior to the date the transportation was to depart.
7. Airport Waiting Time: Waiting time at airports will be subject to an hourly rate or fraction thereof after a free allowance of (1) hour. This hourly rate is not included in the estimated garage to garage rate and will be based on the type of vehicle.

### Hourly Rates:

Minimum charge will be for 3 hours:	\$435.00 per 3 hour Minimum
Additional half hours, or any fraction thereof:	\$ 97.50 per half hour
11-15 Passenger Luxury Vehicle:	\$165.00 per hour
Additional Half Hour, or any fraction thereof:	\$ 97.50 per half hour

### Wedding & Prom Package Deals:

Wedding packages have a minimum rental of 4 hours: (Not including gratuities.)	\$230.00 Per hour
Proms packages have a minimum rental of 8 hours: (Not including gratuities.)	\$165.00 Per hour

Late Cancellations or Changes: Any changes to a reservation less than 24 hours' notice may be subject to a \$25.00 fee. There will be a late cancellation fee of 25% for all reservations not canceled before 5pm the prior day. Any reservations canceled on the day of service are subject to full payment with no refunds.

Damage Fee: A client is solely responsible for any damage done by them to a vehicle during their time of rental. Minimum cleaning fee is \$250.00. Any replacement or repairs will be based on estimates given to complete work.
