

NOTE 1 - Traveling charges (Column 1) are in addition to hourly rates (Columns 2, 3 and 4).

NOTE 2 - Hourly rates (Columns 2, 3 and 4) are based on the day or days as indicated, during which services are performed.

NOTE 3 - Hourly rates (Columns 2, 3, and 4) computed in half-hour periods; fractions of one-half hour considered as one-half hour.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 7 hours plus applicable travel time at rates named in Columns 1 and 2. Fridays and Saturdays (any hour) or Monday-Thursday (6:01PM to 5:59AM): 2 hours plus applicable travel time at rates named in Columns 1 and 4. Monday-Thursday (6:00AM to 6:00PM): 2 hours plus applicable travel time at rates named in Columns 1 and 3.

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from final destination back to carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps. MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.

In lieu of the applicable rates provided for in Tariff Freight PA. P.U.C. No. 51-W, the following rates shall apply:

NOTE 1 - LABOR RATE (Item 120) - Labor Rates shown for Berks County will apply for all counties within Pennsylvania.

NOTE 2 - ADDITIONAL TRANSPORTATION CHARGE (Item 160) - Rates shown under Group 1 will apply for all counties within Pennsylvania except when origin or destination is in Philadelphia or Allegheny Counties. When the origin or destination of the shipment is in Philadelphia or Allegheny Counties, rates shown under Group 2 will apply at both origin and destination.

NOTE 3 - EXTRA PICKUP AND/OR DELIVERY (Item 230) - Rates shown under Schedule D will apply for all counties within Pennsylvania.

NOTE 4 - OVERTIME LOADING/UNLOADING (Item 240) - Rates shown for Berks County will apply for all counties within Pennsylvania.

NOTE 5 - ELEVATORS, STAIR CARRY, EXCESSIVE DISTANCE (Item 260) - Rate shown under Schedule D will apply for all counties within Pennsylvania.
