TO ALL PARTIES OF RECORD

Application of the Department of Transportation of the Commonwealth of Pennsylvania for approval to replace the public above grade crossing by the installation of a new structure where State Route 0291 (Governor Printz Boulevard) crosses the tracks of Consolidated Rail Corporation (Conrail) (DOT# 589 291 W) in Tinicum Township, Delaware County, and the allocation of costs incident thereto.

To Whom It May Concern:

By Secretarial Letter dated January 25, 2018, the Department of Transportation of the Commonwealth of Pennsylvania (Department) was directed to complete the subject crossing alteration on or before December 31, 2024.

By petition received by the Commission on October 9, 2025, the Department requested an extension of time to August 31, 2032, to complete the alteration of the subject crossing due to unforeseen design delays and a late construction start.

We have carefully reviewed the record in this proceeding and will grant the Department an extension of time to August 31, 2032, to complete the alteration of the above captioned crossing.

This Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code.

THEREFORE:

The petition of the Department of Transportation of the Commonwealth of Pennsylvania received by the Commission on October 9, 2025, requesting an extension of time, be and is hereby granted to the extent herein directed:

1. Paragraph 12 of our Secretarial Letter dated January 25, 2018, which reads as follows, to wit:

“12. All work necessary to complete the alteration of the subject crossing be done in a manner satisfactory to this Commission on or before December 31, 2024, and that on or before said date, Pennsylvania Department of Transportation report to this Commission in writing the date of actual completion of the work.”

be and is hereby modified to read:

12. All work necessary to complete the alteration of the subject crossing be done in a manner satisfactory to this Commission on or before August 31, 2032, and that on or before said date, Pennsylvania Department of Transportation report to this Commission in writing the date of actual completion of the work.

2. In all respects not inconsistent herewith, our Secretarial Letter dated January 25, 2018, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.



If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
