Application of Crown Castle Fiber, LLC for approval of the alteration of the at-grade crossing where State Route 4004 (Cannelton Road) crosses track of Youngstown and Southeastern Railroad Company, Inc. (DOT 869 975 T) by the installation of aerial communication line in Darlington Township, Beaver County.

To Whom It May Concern:

By application received by the Commission on March 6, 2026, Crown Castle Fiber, LLC (Crown Castle) seeks Commission approval to alter the at-grade crossing (DOT 869 975 T) by the installation of a new aerial communication wire and strand where State Route 4004 (Cannelton Road) crosses track of Youngstown and Southeastern Railroad Company, Inc (YSRR) Company in Darlington Township, Beaver County.

Crown Castle proposes the installation of a new aerial communications cable and strand within the joint right of way of State Route 4004 (Cannelton Road) and YSRR. The proposed cable and strand will be installed above the existing minimum overhead clearance of 27.3 feet above the track.

The Commission hereby establishes its jurisdictional limits at the subject crossing as the area within the confines of the railroad right-of-way and the highway right-of-way.

In its application, Crown Castle states that the proposed aerial wire is necessary to provide adequate, efficient, and reasonable communication facilities to the public in Beaver County and surrounding areas. Crown Castle will be directed to perform the necessary installation, provide for maintenance and protection of highway and pedestrian traffic during installation and accept future maintenance responsibility for the proposed facilities, at its sole cost and expense.

All work is to be performed in accordance with the plan hereby entitled: "EXHIBIT A" consisting of two (2) sheets submitted to the Commission with the application on March 6, 2026.

Crown Castle has served a copy of the application and plan on Darlington Township, Beaver County, Penn Power, YSRR, Windstream/Uniti, and the Pennsylvania Department of Transportation. All parties were queried by letter dated March 11, 2026, sent via email as to any objection to the subject application and plans, and none of the parties have responded with any objections.

The Commission has exclusive jurisdiction in crossing alterations and is the final arbiter of any fees associated with a crossing application. Any conditions, including fees associated with a crossing application, must be approved by the Commission.

Upon full consideration of the matters involved, we find that a hearing is not necessary and that a Secretarial Letter may be issued approving the application.

The Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code and finds that the alteration of the crossing is necessary and proper for the service, accommodation, convenience or safety of the public.

The application of Crown Castle Fiber, LLC approved as herein directed:

1. The caption of the subject proceeding is hereby revised as shown herein.
2. The crossing where State Route 4004 (Cannelton Road) crosses, at grade, track of Youngstown and Southeastern Railroad Company, Inc. (DOT 869 975 T) in Darlington Township, Beaver County be altered generally in accordance with the plan hereby entitled: "EXHIBIT A" consisting of two (2) sheets submitted to the Commission on March 6, 2026; which plan is made part hereof and is hereby approved except insofar as it may relate to the division of work, deletion of work, or the allocation of costs and expenses incident to the installation of the project.
3. Crown Castle Fiber, LLC at its sole cost and expense, furnish all material and perform all work necessary to alter the crossing by the installation of a new aerial communication wire and strand, within the right-of-way of the highway where State Route 4004 (Cannelton Road) crosses, at grade, track of Youngstown and Southeastern Railroad Company, Inc. (DOT 869 975 T), all in accordance with the approved plan and this Secretarial Letter.
4. Crown Castle Fiber, LLC at its sole cost and expense, furnish all material and perform all work necessary to establish and maintain any detours or traffic controls that may be required to properly and safely accommodate highway and pedestrian traffic during the time the crossing is being altered.

5. Any relocation of, changes in and/or removal of any adjacent structures, equipment or other facilities of any non-carrier public utility, other than Crown Castle Fiber, LLC incidental to the alteration of the crossing, be made by said public utility at its initial cost, and in such a manner as will not interfere with the alteration of the crossing; and such relocated or altered facilities thereafter be maintained by said public utility, at its sole cost and expense.

6. Youngstown and Southeastern Railroad Company, Inc., at Crown Castle Fiber, LLC sole cost and expense, furnish all material and perform all work relating to its facilities which may be required as incidental to the performance of the proposed work and furnish any watchmen, flagmen, inspectors and/or engineering services that may be deemed necessary to protect the railroad's operations or facilities during the time the facilities are being installed.

7. Crown Castle Fiber, LLC, at its sole cost and expense, furnish all material and perform all work necessary to complete the remainder of the project, and any other ancillary features of the project, generally in accordance with the approved plan and this Secretarial Letter.

8. The alteration of the crossing be completed on or before April 30, 2027, and that on or before said date Crown Castle Fiber, LLC report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plan and this Secretarial Letter.

9. Crown Castle Fiber, LLC, at its sole cost and expense, pay all compensation for damages, if any, due to owners of property taken, injured, or destroyed by reason of the alteration of the crossing in accordance with this Secretarial Letter.

10. All parties involved herein cooperate fully with each other so that during the time the work is being performed, vehicular, pedestrian and railroad traffic will not be endangered or unnecessarily inconvenienced, and so that the requirements of each of the parties will be provided for and accommodated insofar as possible.

11. Crown Castle Fiber, LLC cooperate with the non-carrier utilities involved, so that during the alteration of the subject crossing, the facilities of the non-carrier utilities will not be endangered or unnecessarily interrupted.

12. Crown Castle Fiber, LLC, at least seven (7) days prior to the start of work, notify all parties in interest of the actual date on which work will begin.

13. Upon completion of the alteration of the crossing, Crown Castle Fiber, LLC, at its sole cost and expense, furnish all material and perform all work necessary thereafter to maintain its new aerial wire and duct, and any ancillary facilities installed in accordance with the approved plan and this Secretarial Letter.

14. Upon completion of the alteration of the crossing, Youngstown and Southeastern Railroad Company, Inc. at its sole cost and expense, furnish all material and perform all work necessary to maintain its railroad facilities at the crossing and maintain at all times in a smooth and satisfactory condition the high type concrete crossing surface, all in accordance with Part 8 of the Manual on Uniform Traffic Control Devices and this Secretarial Letter, and provide Darlington Township at least ten (10) business days advance notice when performing any work as directed by this paragraph.

15. Upon completion of the alteration of the crossing, the Pennsylvania Department of Transportation at its sole cost and expense, furnish all material and do all work necessary thereafter to maintain the highway approaches up to the concrete crossing surface and, in addition, maintain the grade crossing advance warning signs, stop lines and pavement markings, if required, all in accordance with Part 8 of the Manual on Uniform Traffic Control Devices and this Secretarial Letter; and provide Youngstown and Southeastern Railroad Company, Inc. and Darlington Township at least ten (10) business days advance notice when performing any work as directed by this paragraph.

16. Upon completion of the work herein directed, and upon written request from any party of record, this proceeding be scheduled for a hearing at a time and place to be determined by the Commission, for the purpose of taking testimony upon the final allocation of any remaining costs incurred by the non-carrier utility companies and other matters relevant to this proceeding.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.

All formal documents must be filed with the Secretary of the Commission. Documents must be eFiled, mailed or hand delivered. All filings should be addressed to the Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. The Commission will not accept documents delivered by fax or by e-mail. If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
