Priority Power Management, LLC ("Priority Power") submits this letter to provide formal notice of an internal brand consolidation and to request relinquishment of certain licenses associated the entities described below, effective upon the Commission's processing and acceptance of this notice.

Priority Power has historically owned and operated the following brands/entities:

- Satori Enterprises LLC d/b/a Satori Energy
- Energy Solutions USA, LLC

As part of a corporate brand consolidation, Priority Power has consolidated all operations, branding, and commercial activity under Priority Power Management, LLC. This transition is administrative in nature and does not reflect a withdrawal from the market.

Importantly:

- Satori Enterprises, LLC does not currently have any customers.
- There has been no interruption of service, and no customers are being transferred or abandoned as a result of this consolidation.
- All ongoing or future regulated activities are conducted solely under Priority Power Management, LLC.

Although Priority Power is requesting relinquishment of the licenses associated with Satori Enterprises LLC, Priority Power acknowledges and affirms responsibility for any applicable compliance obligations related to those entities, including obligations that may survive license relinquishment under applicable law or Commission rules.

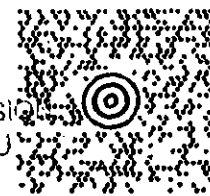

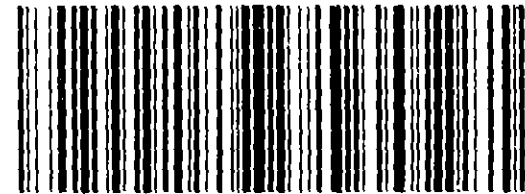

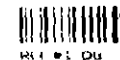
