Dear Secretary Homsher:

Enclosed for filing is the executed **CONFIDENTIAL** Conservation Service Provider (“CSP”) contract between PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) and the CSP selected to implement the Business (Non-Residential) Program under the Company’s Phase V Energy Efficiency and Conservation (“EE&C”) Plan. In addition, this filing includes **CONFIDENTIAL** copies of PPL Electric’s: (1) cover sheet summarizing the aspects of the contract as required by the Pennsylvania Public Utility Commission’s (“Commission”) *Phase V Implementation Order*<sup>1</sup>; and (2) bid evaluation summary (including the number of bids that were received, justification for selection of CSP if based on receipt of less than three bids, and explanation for non-selection of low-bid CSP, if applicable).
