Enclosed for filing please find the Application of EnergyNation Solutions LLC d/b/a/ EnergyNation ("Applicant") to provide service as a Broker/Marketer of Natural Gas Supply throughout the Commonwealth. Please note that Attachment F and the Tax Certification Statement to the Application contain confidential information and have been marked as such. **The Applicant respectfully requests confidential treatment of these Exhibits, and they are being provided in a separate envelope for filing under seal.**

A check for the filing fee is also enclosed. Copies of this Application have been served on all of the Natural Gas Distribution Companies in the Commonwealth and the required statutory advocates, the Attorney General, and the Department of Revenue, in accordance with the attached Certificate of Service.

Request for Waiver of Publication

At this time, the Applicant respectfully requests a waiver of the requirement to publish notice of the filing of the Application in the required newspapers in Pennsylvania, for the following reasons. The Applicant filed a nearly identical NGS broker application in January of this year, which was assigned docket number A-2026-3060350. At the same time, Applicant filed an EGS broker application, which was assigned docket number A-2026-3060264. Notices of both applications were simultaneously published in all of the required newspapers in February, as confirmed by the publication notices included herewith.

The Applicant's original NGS broker application was subsequently rejected for having missing certain information on page 9 of the application, several weeks after the publication had occurred.

No protests or objections were received in response to either the Applicant's EGS or NGS broker applications. The Applicant's new NGS broker application is substantially identical to application previously filed in January, with the exception of the corrected page 9. In light of the very recent publication of the Applicant's NGS application, the fact that the new application is substantially identical to the prior application, and the lack of any protests or objections to the prior application, Applicant would respectfully request that the Commission exercise its
