Application of Aqua Pennsylvania, Inc. for approval to alter the public crossing (DOT 588 600 D) by the installation of an underground 16-inch ductile iron watermain within a 24-inch steel casing where State Route 0029 (Bridge Street) crosses, below grade, the tracks of Norfolk Southern Railway Company located in Phoenixville Borough, Chester County.

To Whom It May Concern:

This matter is before the Commission by reason of a request from Aqua Pennsylvania, Inc. received by electronic mail on April 1, 2026. Aqua Pennsylvania, Inc. notified a Commission staff engineer that the subject project has been suspended indefinitely and that it wishes to withdraw the subject application.

Upon full consideration of the matters involved in this proceeding, we find that our Secretarial Letter dated April 1, 2025, approving the subject application and plans can be rescinded and the application in this matter can be withdrawn.

The Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code, THEREFORE:

1. The Secretarial Letter dated April 1, 2025, be rescinded.
2. The application received by the Commission on December 18, 2024, be withdrawn.
3. The case be "CLOSED."

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.

All formal documents must be filed with the Secretary of the Commission. Documents must be eFiled, mailed or hand delivered. All filings should be addressed to the Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120. The Commission will not accept documents delivered by fax or by e-mail. If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
