

On February 12, 2026, I issued Prehearing Order #5 granting the Joint Motion and amending the litigation schedule as follows:

Direct Testimony	March 6, 2026
Rebuttal Testimony	March 30, 2026
Surrebuttal Testimony	April 20, 2026

On April 2, 2026, counsel for Conneaut Lake Park Water Corporation, Inc. (CLPWC) filed a Motion to Amend Prehearing Order #5 (Motion) to permit CLPWC witnesses Matthew Elchert, Steven Halmi, and Jaclyn McCoy to testify video during the in-person evidentiary hearings. As reason for the request, counsel for CLPWC cited the distance between Harrisburg and the witnesses' locations in Northwest Pennsylvania.

On April 9, 2026, Aqua Pennsylvania, Inc. filed its Answer to the Motion indicating that it had no objection to CLPWC's request.

As of the date of this Order, no other party has filed any objections to CLPWC's Motion.

Upon careful consideration, I shall grant the Motion and amend Prehearing Order # 5 to allow CLPWC witnesses Matthew Elchert, Steven Halmi, and Jaclyn McCoy to testify remotely at the evidentiary hearings scheduled for May 4-5, 2026. However, instead of testifying via video, these witnesses shall be allowed to testify via telephone.
