Dear Secretary Homsher:

On April 1, 2026, Pennsylvania-American Water Company (“Company”) reported to the Pennsylvania Public Utility Commission (“Commission”) on the Company’s residential customer accounts which have accumulated \$10,000 or more in arrearages.

Following a secondary review, the Company has determined that 18 accounts included in the report required correction. Of these, 3 accounts were identified as commercial accounts and were therefore removed from the residential arrearage report. The remaining 15 accounts had incorrectly reported ten-day termination notice counts due to human error. These values have since been reviewed and corrected.

An updated report reflecting these corrections has been prepared for the Commission’s records. The Company regrets the error and appreciates the opportunity to provide corrected information to ensure the accuracy of our regulatory reporting.
