Please accept this letter as the response of Evergreen Gas & Electric, LLC ("Evergreen") to your letter of April 15, 2026.

On April 1, 2026 Evergreen filed its Application for Approval to Offer, Render, Furnish or Supply Electricity Supply Services as a Supplier throughout the Commonwealth. 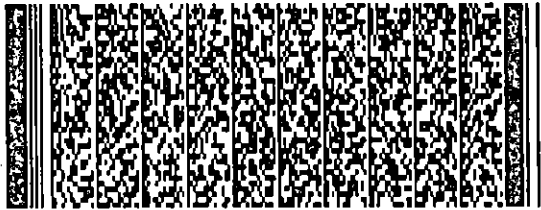

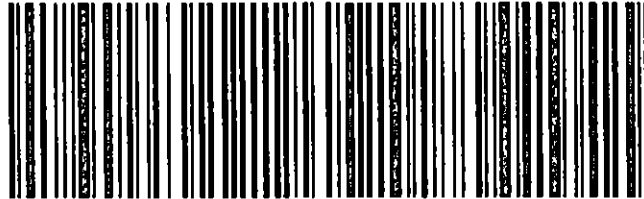
