Request for Information

- 1) The responses to questions 5(a), 5(b), 5(c), 5(d) and 5(e) of the verified statements are insufficient. Title 52 Pa. Code § 29 provides detailed requirements. **Please provide a system which incorporates code specified compliance requirements – you must look up and provide the PUC with the required information regarding frequency and retention of driver records – you have not previously answered that question. A general answer will not be sufficient. You must look up specifics in the Title 52.** Each of your answers to sections of this question were insufficient:
 - § 29.503. Age restrictions.
 - § 29.504. Driver history
 - § 29.505. Criminal history.
