Dear Secretary Homsher,

Bio-Diversity LLC respectfully submits these comments in response to the Commission's Tentative Order issued April 16, 2026, which proposes the cancellation of our Certificate of Public Convenience.

We are a small, family-owned company that primarily engages in the manufacturer of Wood blocks and pellets. We also provide private transportation of the products that we ourselves produce. Because we have not been providing for-hire (common or contract) motor carrier service to third parties, we have reported zero gross intrastate operating revenue for the past two years. This situation triggered our inclusion in Appendix A of the Tentative Order.

We fully understand the Commission's goal of removing inactive carriers from its regulated roster. However, we respectfully request that the Commission not cancel our Certificate of Public Convenience (Utility Code A-8917478, Docket No. A-2015-2473382). We wish to retain this authority for flexibility and future growth of our business. Retaining the certificate will allow us to respond quickly to potential new opportunities to provide for-hire transportation services in Pennsylvania should market conditions or business needs change. We intend to remain in compliance with all PUC reporting and insurance requirements going forward.
