ORDER #2
HOLDING PROCEEDINGS IN ABEYANCE

On February 6, 2026, UGI Utilities, Inc. – Gas Division filed an Application seeking approval pursuant to Sections 1102(a)(3), 1103(a), and 2102(b) of the Pennsylvania Public Utility Code (“Code”) to transfer the Auburn City Gate Stations located in Auburn Township, Susquehanna County, Pennsylvania, to UGI Auburn Gathering, LLC. UGI Gas also seeks approval of a modification of an existing affiliated interest agreement pursuant to Section 2103 of the Code.

On March 9, 2026, the Procter & Gamble Paper Products Company filed a Petition to Intervene. This Petition was granted via Order issued on March 31, 2026.

On March 9, 2026, BKV Operating, LLC filed a Petition to Intervene and Protest, which was amended on March 27, 2026.

On March 27, 2026, UGI Gas filed Preliminary Objections to BKV’s Petition to Intervene and Protest. BKV filed an Answer to UGI Gas’s Preliminary Objections on April 10, 2026.

On March 30, 2026, UGI Gas filed an Answer with New Matter to BKV's Petition to Intervene and Protest. BKV filed a Reply to UGI Gas's New Matter on April 20, 2026.

A prehearing conference has been scheduled for this case for May 5, 2026. A prehearing conference order was issued directing that the parties file prehearing conference memorandum by May 4, 2026. The Preliminary Objections filed by UGI Gas are currently outstanding.

On April 24, 2026, via email, I was informed by UGI Gas and BKV that the parties have reached a settlement in principle. UGI Gas and BKV requested that I hold this matter in abeyance for 10 days to allow the parties to finalize the settlement. I formally granted this request via an Order that was issued on April 28, 2026.

On April 30, 2026, via email, UGI Gas and BKV made a request to hold this matter in abeyance for an additional period of time to and including May 15, 2026, to allow sufficient time for the parties to finalize the potential settlement. UGI Gas and BKV further requested that the prehearing conference be continued, including the deadline for the filing of prehearing conference memorandum, to a date after May 15, 2026. By email, I informed the parties: (1) that this proceeding would be held in abeyance until May 15, 2026, (2) that the prehearing conference would be cancelled and that the parties were not required to file prehearing conference memorandum, and (3) that I would wait to hear from the parties prior to rescheduling the prehearing conference. This Order formally grants the requests of UGI Gas and BKV.
