

NOTICE OF COMPLAINT

- A. You must file an Answer within twenty (20) days of the date of service of this Complaint. The date of service is the mailing date as indicated at the top of the Secretarial Letter for this Complaint and Notice, 52 Pa. Code §1.56(a). An Answer is a written explanation of circumstances wished to be considered in determining the outcome. The Answer should raise all factual and legal arguments that you wish to claim in your defense and must include the reference number of this Complaint. Your Answer must be verified and the original **mailed to**:

Or you may **eFile your Answer** using the Commission's website at www.puc.pa.gov. The link to eFiling is located under the Filing and Resources tab on the homepage. If your Answer exceeds 250 pages, you must also file a paper copy with the Secretary's Bureau.

- B. If you fail to answer this Complaint within twenty (20) days, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a penalty. The penalty could include a civil penalty, the suspension or revocation of your operating authority, or other such remedy.
- C. You may elect not to contest this Complaint by paying the fine proposed in this Complaint by certified check or money order. **Payment must be made to "Commonwealth of Pennsylvania"** and should be forwarded to:

- D. Your payment is an admission that you committed the alleged violation and an agreement to cease and desist from further violations. Upon receipt of your payment, the Complaint proceeding shall be closed.
- E. If you file an Answer, which admits or fails to deny the allegations of the Complaint, the Bureau of Investigation and Enforcement will request that the Commission issue a Secretarial Letter imposing a fine and/or other such remedy.
- F. If you file an Answer which contests the Complaint, the matter will be assigned to an Administrative Law Judge (ALJ) for hearing and decision. The ALJ is not bound by the requested civil penalty.
- G. If you are a corporation, you must be represented by legal counsel. 52 Pa. Code §1.21.

MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (Commission or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement -Motor Carrier Division hereby represents as follows:

1. That BEST OF TIMES CHAUFFEURED LIMOUSINE SERVICE INC, Respondent, maintains a principal place of business at 741 Bellingham Lane, Harleysville, PA 19438.
2. That on July 22, 1996, Respondent was issued a certificate of public convenience by this Commission, to transport, as a common carrier, persons, in limousine service, between points in the counties of Chester and Montgomery and from points in said counties to points in Pennsylvania and return at PUC Utility Code 640399.
3. That on November 18, 2025, PUC Motor Carrier Compliance Supervisor Tatjana Roth emailed Mark Barnett, Respondent’s owner, requesting that the attached application for abandonment be submitted due to Respondent having been sold to Bella Transportation and the new owners not intending to transfer the limousine authority.

That Respondent, by failing to file an application with this Commission prior to abandoning or discontinuing service, violated 66 Pa. Code §1102(a)(2); 52 Pa. Code §3.381(a)(1)(v). The penalty for this violation is cancellation of the certificate held by Respondent with this Commission at PUC Utility Code 640399.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued to BEST OF TIMES CHAUFFEURED LIMOUSINE SERVICE INC, at PUC Utility Code 640399.
