I am writing in response to the questions from the Public Utility Commission, on account A-2026-3061741.

1.) You list agricultural products as a commodity.

A.) Please explain in detail what 3rd party hires you for the transportation of these items and explain how they are not related to your work as an organic producer company

Response:

Tuscarora Grain Co., LLC is looking at opportunities to haul grains, feed, feed by products, and feed ingredients in Pennsylvania. Feed mills would hire us to haul from locations in Pa and to deliver at another location or customer of grain or feed, sometimes at other commercial feed mills. We are looking to haul feed ingredients like wheat middlings which are produced at flour mills and then hauled to feed mills in Pennsylvania. There is opportunity to haul organic soybean meal from commercial storage in Lebanon Pa to feed mills across the state.

B.) A PUC certificate is not needed for products you own and transport (purchase sell). If this is the case, then you should withdraw your application.

Response:

In reading the rules of hauling in Pa, we believe that grains going from feedmill to feedmill and hauling ingredients that are by products would require us to have a PUC certificate, for products that we do not own.
