To Secretary Homsher,

I am filing these formal comments to contest the Tentative Order entered on April 16, 2026.

The Order suggests that because VI MOVEMENTS LLC reported zero revenue for 2024 and 2025, the business is non-compliant with the operational requirements of 66 Pa. C.S. § 1501 and 52 Pa. Code §§ 29.61-62. I respectfully disagree based on the following:

1. While my Assessment Reports for 2024 and 2025 correctly reflect \$0 in gross intrastate operating revenue, this is because my operations during this period were strictly interstate.
2. My company has remained active and operational throughout 2024 and 2025. I have maintained my equipment and authority to serve the public; I simply did not perform moves or transport within the borders of Pennsylvania that would generate "intrastate" revenue.
3. I wish to maintain my Certificate of Public Convenience for future intrastate opportunities.

I request that the Commission not cancel my Certificate and not direct the Department of Transportation to suspend my vehicle registrations under 75 Pa. C.S. § 1375. I have met my reporting obligations by filing the required "zero" reports as an active interstate carrier.

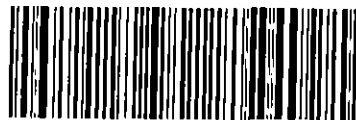
