I am writing on behalf of Reliance Non-Emergency Medical Transport Inc. in response to the Tentative Order proposing cancellation of our Certificate of Public Convenience.

Please accept this letter as formal notice that we respectfully contest the proposed cancellation.

While prior reports reflect zero revenue, the company is not inactive. We are currently in the stages of securing required insurance contract and executing broker agreements necessary for reimbursement of non-emergency medical transportation services. This process has delayed revenue generation, as authorization to bill and receive payment is still pending.

Reliance Non-Emergency Medical Transport Inc. is otherwise fully prepared to operate and intends to commence and expand services immediately upon completion of these arrangements. The absence of reported revenue is due solely to administrative and reimbursement setup delays, not a lack of operational readiness or intent.


We remain fully committed to providing transportation services within the Commonwealth of Pennsylvania and to complying with all applicable requirements of the Public Utility Commission.
