I am writing to you regarding the Tentative Order- Docket No. M-2026-3061024, USPS post marked April 21, 2026 that we have received from the Public Utility Commission. As instructed in paragraph 4, page 3 of the notification this is notice is to supply comments to challenge cancellation of the Certificate of Public Convenience.

Due to a reduction in our employee workforce in previous years and the ongoing search to hire qualified commercial drivers, our main source of revenue has been generated from our excavation business, transportation of our own property. As you are aware, the ongoing struggle to hire employees and qualified commercial drivers is a situation that many companies continue to experience.

On March 9th of this year (2026) Lloyd Excavating, Inc. hired on an employee and qualified commercial driver which, has led us to generate gross PA Net Intrastate Operating Revenue within the first quarter of 2026 and continues to date. Additionally, we continue our ongoing candidate search for employees and qualified commercial drivers.

With this updated year to date (2026) information, I ask that the Pennsylvania Public Utility Commission rescind the pending cancellation of our Certificate of Public Convenience. I appreciate your time and await your response to this request.

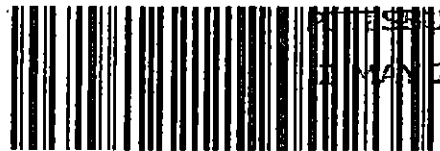

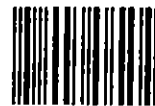

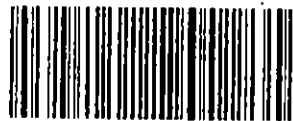
