I am writing in response to the Tentative Order I received on 4/25/2026 regarding you not receiving my 2025 Assessment Report-Motor Carriers.

My Trade name is Stephen Fowler, and my Utility Code is 8915934. The assessment report was submitted electronically 3/9/2026. I am sending a copy of the confirmation I received when it was completed and sent.

As indicated by my assessment report, \$32,000.00 revenue was reported. Since my truck is used exclusively for the transportation of wood products from wood lots, the revenue was then deducted in full as per exemption #7. Supporting documentation was with report.
