Re: Cancellation of Certificates of Public Convenience for Telecommunication Utilities; Failure to Operate or Report Any Intrastate Operating Revenue at Docket No. M-2026-3059781

Dear Leonard Bittner:

On March 12, 2026, the Commission entered a Tentative Order in the above captioned proceeding to initiate a process to cancel the Certificate of Public Convenience (CPC) of telecommunications public utilities that have reported zero gross intrastate revenue for the past three years. The Tentative Order was mailed to each telecommunications public utility in question via United States Postal Service on or around March 12, 2026, and was published in the Pennsylvania Bulletin on March 28, 2026. 56 Pa. B. 1797. Affected utilities were given twenty (20) days from the March 28, 2026 publication (April 17, 2026) to challenge the cancellation of their respective CPC or file a conforming Assessment Report.

The telecommunications public utilities served with the March 12, 2026 Tentative Order were those that reported zero gross intrastate operating revenue on the annual revenue reports required by Section 510(b) of the Code or failed to file an annual revenue report entirely. Moreover, the Tentative Order warned affected utilities that failure to comply would result in the Commission taking appropriate action to cancel their CPCs.¹


By way of background, the Public Utility Code requires that by March 31 of each year, every public utility must file a report detailing its gross intrastate operating revenue for the preceding calendar year. 66 Pa. C.S. § 510(b). This report is essential for the Commission to fund its operations and to properly allocate assessment costs among the regulation utility community. *Id.* In addition, telecommunications public utilities are required to operate continuously and without unreasonable interruptions of service.

¹ Affected telecoms that filed comments through anyone other than those recognized as authorized to represent a public utility in an adversarial or nonadversarial proceeding were not considered. *See* 52 Pa. Code §§ 1.21 (Appearance) and 1.22 (Appearance by attorney or certified legal intern).

66 Pa. C.S. § 1501. A failure to file under Section 510, or a demonstration of several years with no intrastate operating revenues indicates that a utility is no longer providing jurisdictional public utility service in Pennsylvania and, therefore, a CPC for that entity is no longer “necessary or proper for the service, accommodation, convenience, or safety of the public.” 66 Pa. C.S. § 1103(a).

By this Secretarial Letter, the operating authority conferred on Dial World Communications, LLC through its CPC at Docket No. A-2010-2155221 is hereby cancelled and may no longer be used to provide public utility service in Pennsylvania.
