

Request for Information

- 1.) For the Public Utility Commission to get a better understanding of your proposed transportation services.
 - A.) Please explain where your transportation clients will come from. Meaning, will this service be open to the public or will all transportation clients be receiving home health care services from Karma Healthcare LLC?
 - B.) Please describe your transportation marketing strategies for the general-public.
 - C.) Service provided through another government agency such as Medicaid or Pennsylvania Department of Health's office of development programs do not fall under PUC regulations or oversight. If this is the case, then you should withdraw your application.
 - Furthermore, please be aware that all PUC certificated revenue is subject to annual reporting and billing.
- 2.) Question # 5 of the Verified Statement. Provide compliant policies that satisfy the requirements of 52 Pa Code with revision to specific chapters below. Please review Title 52 information online, which may be accessed at www.pacode.com
 - A.) § 29.504. Driver's license checks. How often will this be done?

B.) § 29.505. Criminal history checks. How often will this be done?

3.) Financial Position. At this it is expected that the Company's bank account is ready to commence operations by having the financial ability to provide safe, efficient and reliable service. Any assets which may need transferred to the applicant (Karma Healthcare LLC) should happen prior to adding them to the balance sheet.

A.) Provide a complete, dated Balance Sheet showing values of the assets and debts held by the applicant.

B.) Provide a copy of a bank statement (with account number redacted), or an official notarized letter from a bank officer, verifying the acceptable account holdings for Karma Healthcare LLC.

C.) Submit proof of ownership of the claimed vehicle, such as copies of the registration, title, etc. All proof must be in the name of the applicant "Karma Healthcare LLC" or remove this personal item from the applicant's Balance Sheet.

As per 52 Pa. Code §41.14, applications may be denied if the applicant fails to satisfy fitness standards. Be advised that additional corrections may not always be requested; therefore, prior to submitting your responses, your consultation with an attorney or financial expert familiar with Commission regulated Motor Carrier-related proceedings is highly encouraged.
