I have an interest in this proceedings as a utility rate payer, a land owner and a business owner.

As a resident near the proposed facilities, I enjoy the scenery & natural landscape of our area. I also appreciate the important part the wildlife and indigineous insects of our area hat play an important part of the health and overall welfare of our community. I am also suseptible to health issues that cause me concern for the types of health risks that this line may bring to myself and

other member of my household. I am especially concerned how the proposals of this company will impact my utility rates and how those increasing rates will limit my ability to not only pay them, but also my other bills. I am concerned how increasing utility rates will limit my ability to sell my property to those looking to purchase, if rates increase then others will not be willing to purchase homes in our area and my own ability to sell will be affected as well as neighbors which will cause blight & safety concerns in our community if rates become unaffordable and people must move away.

5. State Petitioner's position on the issues in the proceeding. 52 Pa. Code § 5.73(a)(3).

In consideration of 52 Pa. Code Section 57.76(a), I do not believe that there is a need for this line. Any benefit would not be for myself and others in this area who would be paying for it..I should not be required to bear these losses to provide benefit to others outside of my area. The risks to the health and safety of the public in this area include me and are unreasonable. The natural resources that will be affected will be forever changed, lost or modified, which will not be minimum as an adverse environmental impact. The need for this line has not been demonstrated to be of benefit to this area, however, will result in brown outs or worse, to our services. There are other available alternatives that should be utilized rather than allowing this line.


