Application of the York County Board of Commissioners for approval of the alteration of the crossing (DOT 978 948 W) located where York County Bridge No. 81 (West College Avenue) crosses, above grade, the tracks of York Railway Company, located in the City of York, York County.

To Whom It May Concern:

By Secretarial Letter dated May 23, 2023, York County Board of Commissioners was directed to complete the subject crossing alteration on or before December 31, 2026.

On May 6, 2026, the Commission received a petition from York County Board of Commissioners requesting an extension of time to December 31, 2027, to complete the alteration of the subject crossing due to unforeseen delays.

We have carefully reviewed the record in this proceeding and will grant York County Board of Commissioners an extension of time to December 31, 2027, to complete the alteration of the subject crossing captioned above.

This Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code.

THEREFORE:

The petition of York County Board of Commissioners received by the Commission on May 6, 2026, requesting an extension of time, be and is hereby granted to the extent herein directed:

1. Paragraph 11 of our Secretarial Letter dated May 23, 2023, which reads as follows, to wit:

“11. All work necessary to complete the alteration of the subject crossing be done in a manner satisfactory to this Commission on or before December 31, 2026, and that on or before said date, the York County Board of Commissioners report to this Commission in writing the date of actual completion of the work.”

be and is hereby modified to read:

11. All work necessary to complete the alteration of the subject crossing be done in a manner satisfactory to this Commission on or before December 31, 2027, and that on or before said date, the York County Board of Commissioners report to this Commission in writing the date of actual completion of the work.

2. In all respects not inconsistent herewith, our Secretarial Letter dated May 23, 2023, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.


All formal documents must be filed with the Secretary of the Commission. Documents must be eFiled, mailed or hand delivered. If your filing contains confidential material, you are required to file by overnight delivery to ensure the timely filing of your submission. There are certain filings that cannot be eFiled, such as filings containing confidential or proprietary material. These must be submitted to the Secretary by overnight delivery, priority, or certified mail to allow tracking of your filing.

If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
