

- 2.) You failed to answer Question #5 of the Verified Statement of Applicant. Please provide compliant policies/plans for the hiring/employment of prospective drivers. **Please review the regulations found in Title 52 Pa Code §31.134, Title 52 Pa Code §37.204, and 49 CFR §391 to see what is required of Household Goods in Use carriers.**
 - a. Your system for conducting criminal background checks;
 - i. How often will you conduct a criminal background check?
 1. In your previous response to the Commission's request for additional information, you stated that criminal background checks would be conducted prior to hiring and may be conducted periodically (annually). Please clarify if this means that they will be conducted annually or that they may be conducted annually. Please note that this policy must fully comply with the regulation found at Title 52 Pa Code §31.134(b).
 - ii. How will you maintain records (record retention) of the criminal background checks performed.
