I am writing to provide a formal comment regarding Docket No. A-2011-2257077. After reviewing the applicable requirements and my obligations under this docket, I believe that I am in full compliance with all reporting responsibilities associated with this matter.

I am the sole proprietor of a dump truck (one straight truck only – triaxle) business in New York State. I mostly travel in NY but occasionally work brings me to Pennsylvania. Only very rarely do I haul anything from within PA TO within PA, and I keep track of it every month. In recent years, the only thing I have done within PA would be very rarely hauling to townships directly to the road being worked on and spreading gravel to fix the existing roads.

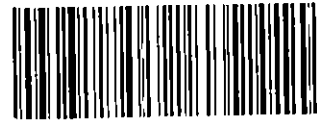
