
I am writing on behalf of A. J. Trunzo, Inc. and in regards to the tentative order for cancellation of Certificates of Public Convenience letter dated: 4/16/26 and received: 4/24/26. We have held our PUC Certificate of Public Convenience since September 13, 1996 (almost 30 years), and we would like to continue holding the license.

Our business has changed over the years. In the past we have hauled materials for other suppliers and customers with our tri-axle dump trucks. In recent years we have concentrated more on hauling our own property (RCA – Recycled Concrete Aggregate) we produce on site, and have been exempt from paying for PA Net Intrastate Operating Revenue.

Due to the economic conditions (fuel & oil prices, etc.) we may require the option to haul for other suppliers and customers. We request that the cancellation process be terminated and our authority maintained. Loss of our Certificate of Public Convenience will create a great financial hardship for A. J. Trunzo, Inc.

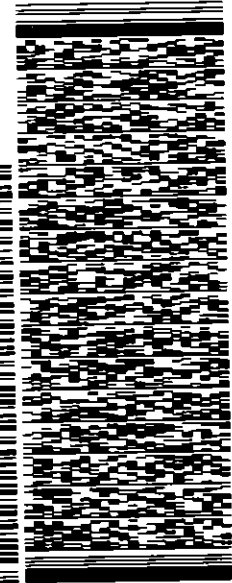
