Long Utility Code 8917512 and docket No. A-2015-2474727 is on that Appendix A list.

I would like to challenge or contest this filing. When I filed my assessment, I did report revenue, then showed that it was due to Exempt transportation of Agricultural Products, resulting in a NET revenue of \$0. Please do not cancel my PUC as I am still operating, just hauling agricultural products.

As It is in the public's best interest for me to still haul their food, please allow me to continue operating, do not allow the Department of Transportation to suspend my vehicle registration.
