Request for Information

- 1.) TML Express LLC was the previous holder of a CPC. During that time, it did not generate PUC accessible revenue. If your company only provides non-jurisdictional motor carrier transportation services in Pennsylvania, the Commission does not require your company to possess a CPC to provide such service. Please explain in detail the for-hire transportation services that fall under PUC jurisdiction.

****NOTE**** The Pennsylvania sales tax exemption is not a valid reason to seek PUC authority. To qualify, you must actually provide for-hire transportation services that fall under PUC jurisdiction. All revenue reported on your annual PUC Assessment Report (AR-XX-MC) is subject to audit. If every transportation service you provide is exempt from PUC oversight, you should not apply for PUC authority. It is unlawful to claim or use sales tax-exempt status when you are not providing qualifying utility services. Individuals or entities that do so may face legal action and prosecution.
