DOT Dumpster Services LLC respectfully requests that the Pennsylvania Public Utility Commission **not** cancel its Certificate of Public Convenience under the above-referenced docket.

DOT Dumpster Services LLC is an active and operating company. Due to the nature of our business, we do not function as a traditional for-hire carrier generating reportable transportation revenue. Instead, we utilize our vehicles and equipment in support of our own operations, including dumpster delivery, waste removal, and related services.

Accordingly, any minimal or zero revenue reported should not be construed as inactivity. Our operations remain consistent and ongoing.

Maintenance of this certificate is necessary for compliance with applicable DOT regulations, insurance requirements, and contractual obligations. Cancellation would materially impact our ability to continue operations.

If the Commission determines that a different classification is more appropriate, DOT Dumpster Services LLC is willing to comply and respectfully requests guidance on any required changes.
