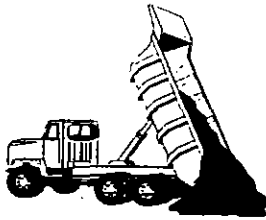

Rupert Trucking LLC - PUC A-8923776- conducts 100 Percent of our business providing dump truck support to utility contractors. All of our operating revenue falls under PUC exemption #4, which reads:

WASTE, EXCAVATED, AND ROAD CONSTRUCTION MATERIALS- You may deduct revenue you received from transporting ashes (including anti-skid, flue dust and fly ash) rubbish and waste for disposal. The PUC also allows the exemption / deduction of any revenue you received for transporting excavated materials in dump trucks. The purpose of the excavation is to create a hole or cavity. Removing material of value for use elsewhere is NOT exempt. The PUC also allows the exemption / deduction of any revenue you received for transporting road construction materials if a dump truck is used, and the materials hauled are used solely in a private or public road project including driveways (but NOT parking lots) and the materials are hauled directly to road construction sites or stockpiles. Carriers may NOT claim a revenue exemption for waste, excavated and road construction materials when those materials were transported in five- axle tractor trailers.

As stated earlier, Rupert Trucking conducts all of our business with tri-axle dump trucks. We solely work for Utility Contractors in South Eastern PA. We provide trucking support to these contractors who replace underground utilities for PECO, PGW and AQUA. All of our work is providing dump trucks for Public Utility Work.

We have always been on time with our reporting, and 100 percent in compliance with exemption #4. ALL of our operating revenue is from trucking for Public Utility Work.

We would respectively like to contest our cancellation.

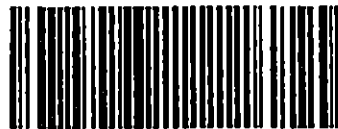
