COMMENTS OF INSINGER TRUCKING LLC

Insinger Trucking LLC ("Insinger" or "the Company"), by and through undersigned counsel/authorized representative, hereby submits these Comments in response to the Commission's Tentative Order entered at Docket No. M-2026-3061024 proposing cancellation of the Company's Certificate of Public Convenience ("CPC").

1. Insinger Trucking LLC Actively Contests Cancellation

Insinger Trucking LLC timely and affirmatively contests the tentative cancellation of its Certificate of Public Convenience. The Company remains actively operating, maintains valid authority, and does not satisfy the criteria warranting cancellation under 66 Pa.C.S. § 1501 or 52 Pa. Code §§ 29.61-62.

2. Insinger Trucking LLC Has Continued Operations

Contrary to the Tentative Order's conclusion, Insinger Trucking LLC has not ceased operations and has continued to offer authorized common carrier transportation services during the relevant reporting periods. The listing of Insinger Trucking LLC in Appendix A appears to be the result of an administrative or reporting discrepancy, not a cessation of service.

3. Reported Revenue Does Not Reflect Lack of Operations

The Tentative Order relies on reports of zero intrastate operating revenue for at least two consecutive years. Any such entries do not reflect an absence of operations, but rather due to revenue generated from activity is exempt.

Insinger Trucking LLC is prepared to supplement, amend, or correct any annual revenue reports the Commission deems necessary.

4. Requested Relief

For the foregoing reasons, Insinger Trucking LLC respectfully requests that the Commission:

- Remove Insinger Trucking LLC from Appendix A of the Tentative Order;
- Withdraw the proposed cancellation of its Certificate of Public Convenience;
- Permit Insinger Trucking LLC, if necessary, to file corrected or supplemental revenue reports to resolve any perceived deficiencies; and
- Retain Insinger Trucking LLC's CPC as active and in good standing.

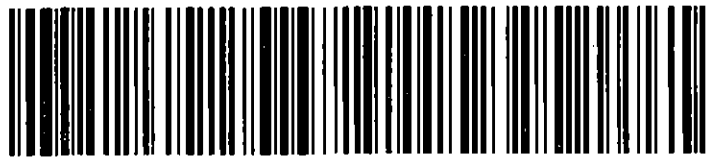
