Your answers should be verified per 52 Pa Code § 1.36. Accordingly, you must provide the following statement with your responses:



Request for Information

- 1.) Describe your utility services in detail. Please explain what transportation services RTI Trucking LLC offer that fall under PUC jurisdiction.

****Note**** The Pennsylvania sales tax exemption is not a valid reason to seek PUC authority. To qualify, you must provide for-hire transportation services that fall under PUC jurisdiction. All revenue reported on your annual PUC Assessment Report (AR-XX-MC) is subject to audit. If every transportation service you provide is exempt from PUC oversight, you should not apply for PUC authority.

It is unlawful to claim or use sales tax-exempt status when you are not providing qualifying utility services. Individuals or entities that do so may face legal action and prosecution.
