This filing is a request for an **INCREASE** in local hourly rates.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

**NOTE 1 - MINIMUM TRANSPORTATION CHARGES:**

Sundays and Holidays (any hour): Eight (8) hours at rates named in Columns 1 and 2.

Saturdays (any hour) or Weekdays (6:01PM to 5:59AM): Four (4) hours at rates named in Columns 1 and 4.

Weekdays (6:00AM to 6:00PM): Three (3) hours at rates named in Columns 1 and 3.

**NOTE 2 -** When a holiday falls on a Saturday, the rates named in Columns 1 and 2 shall be applicable.

**NOTE 3 -** Rates named in Column 4 apply from 6:01PM to 12Midnight on any day when a higher rate is shown for the following day.

**NOTE 4 -** In lieu of rates shown in Tristate 50-T and Tristate 51-W, carrier will supply a TV carton at a rental cost of **\$25.00** per carton.

**NOTE AA -** Applicable only on shipments when the distance from original point of origin to final destination is 20 miles or less - apply one (1) hour at the applicable hourly rates.

**NOTE BB -** Applicable only on shipments when the distance from original point of origin to final destination is more than 20 miles but not exceeding 40 miles - apply one and one-half (1 1/2) hours at the applicable hourly rates.

**NOTE CC -** Shipments that start 30 miles or more from carrier's base will be assessed an additional travel charge of one-half (1/2) hour of the rate based on the number of trucks and the number of men for every 20 miles or fraction of the distance from the carrier's base in Mt. Joy PA.
