
We addressed this issue in December of 2024 with Tatjana Roth via email.

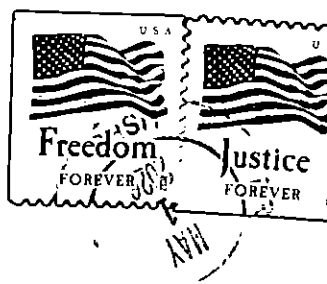
