**Comment in Opposition to Cancellation of Certificate
FBF Transport LLC
PUC 8913703**

To Whom It May Concern:

I am writing on behalf of FBF Transport LLC to respectfully contest the proposed cancellation of our certificate of authority due to the late submission of our 2025 Annual Report of Gross Intrastate Operating Revenue, which was due March 31, 2026.

While it is true that the report was not submitted by the deadline, the delay was not due to any intent to disregard the Commission's requirements. The delay in filing was the result of an internal administrative transition involving office staff turnover. During this period, responsibility for regulatory filings was in the process of being reassigned and unfortunately, this report was overlooked and not submitted by the deadline. We have since submitted the report via the online portal.

FBF Transport LLC values compliance with all regulatory obligations and has made good-faith efforts to maintain our standing with the Commission. This appears to be an isolated incident rather than a pattern of noncompliance. The tentative order notice we received in the mail on April 27th states that *"each carrier listed in Appendix A has reported zero revenue for at least two consecutive years."* According to our records, this is not accurate for FBF Transport. We have reported our revenue each year to date. I included 2023 and 2024 filings with this letter.

Given that the required report has now been submitted, we respectfully request that the Commission reconsider the proposed cancellation and allow FBF Transport LLC to retain
