We received a tentative order for cancellation of certificate of Public Convenience for failure to report positive operating revenue. We called and emailed the PUC office and received the attached email back. (see Attachment)

Through this process and reviewing our 2025 Assessment, the majority of our intrastate operations are exempt materials listed as #4, Waste, excavated, and road construction materials hauled in triaxle dump trucks. However, we have learned that materials hauled in 5 axle tractor trailers are not exempt from the fees. We have (2) 5 axle tractor trailers that pull dump trailers, therefore we would need to continue to have our PUC Authority. We would like to propose to you that we be allowed to refile our 2025 Assessment with the corrected operating revenue for the tractor trailers so that we can pay the PUC the proper fees owed and continue our operations with our PUC Authority.

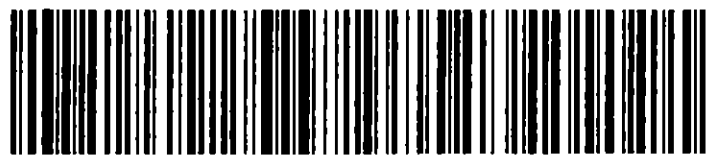
