
**Reply to filing zero INTRA-STATE Revenue:**

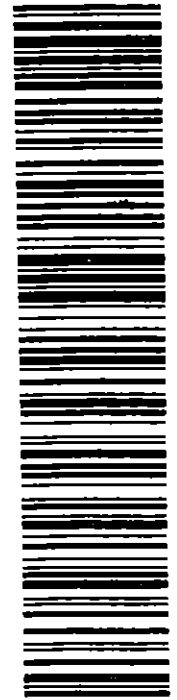
