**RE: Comments in Opposition to Tentative Order — Docket No. M-2026-3061112**

Dear Secretary Hornsher and Members of the Commission:

New Beginnings Moving & Hauling LLC ("NBMH" or "Carrier"), by and through its owner, hereby submits these Comments pursuant to Ordering Paragraph No. 4 of the Tentative Order entered April 16, 2026, in the above-captioned proceeding (Docket No. M-2026-3061112). NBMH respectfully requests that the Commission withhold cancellation of its Certificate of Public Convenience ("CPC") pending review of the circumstances described herein.

### **I. BACKGROUND**

NBMH is an active, lawfully operating motor carrier providing residential and commercial moving services in the Commonwealth of Pennsylvania. The company is headquartered in Royersford, Pennsylvania, and has maintained continuous operations serving the greater Philadelphia metropolitan area.

### **II. BASIS FOR THESE COMMENTS**

NBMH respectfully submits that cancellation of its CPC would be contrary to the public interest for the following reasons:


NBMH did not receive the prior warning letter referenced in the Tentative Order. NBMH was not aware of the deficiency and stands ready to immediately file the required report, a copy of which is submitted simultaneously herewith.

### **III. REQUEST FOR RELIEF**

For the foregoing reasons, NBMH respectfully requests that the Commission:

- (1) Withhold issuance of a Final Secretarial Letter canceling NBMH's CPC;
- (2) Accept the concurrently submitted Annual Assessment Report as satisfying the reporting obligation; and
- (3) Close this proceeding with respect to NBMH upon a finding of compliance.

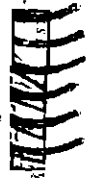
