

in lawful money of the United States of America, which it promises to pay on or before the first day of May, A.D. 1941, at the office of the **Commonwealth Trust Company**, the Trustee in the City of Harrisburg, Pennsylvania, hereinafter called Trustee, with interest at the rate of **five (5) per cent per annum**, payable semi-annually on the first days of May and November in each year at said office, upon presentation and surrender of the annexed coupons, as they severally mature, **both principal and interest in gold coin of the United States of the present standard of weight and fineness or its equivalent**, and free and discharged from all taxes now assessed or levied upon all or any part of the property, rights, franchises or evidence of debt of said Company by the United States or any State, Territory or Municipality, which said Company agrees and promises to pay.

The right is reserved by said Company to pay off the entire issue of bonds or any part thereof, at par and accrued interest, on the first day of May, A.D. 1941 or at any interest-paying time thereafter, although the same may not be due until the first day of May, A.D. 1941, first giving sixty days' notice of such intention, as provided in the mortgage securing the same.

**In case the interest coupons or any part thereof are not paid when they respectively become due and such default shall continue for ninety (90) days thereafter, the principal shall become due notwithstanding the terms hereof**, and the bondholders and the Trustee may thereafter exercise all rights and powers granted to them or any of them under and by the terms and conditions of the mortgage bearing even date herewith.

### TO THE RELEVANT PARTIES:

This letter serves as formal legal notice of an outstanding **Senior First Mortgage Lien** on the infrastructure assets currently involved in the **\$63 Billion merger** between **Essential Utilities, Inc.** (f/k/a Aqua America) and **American Water**.

#### 1. STANDING OF THE CLAIMANT

I, **Luis Francisco**, am the legal holder in physical possession of **52 original First Mortgage Gold Bonds** (Serial Nos. 21–676). These instruments reached maturity in **1941** but were never redeemed. Each certificate remains in my possession with **53 unredeemed interest coupons**, confirming the debt is **Outstanding and Unsatisfied**.

#### 2. CONTINUITY OF THE 1941 INDENTURE

The validity of this debt is confirmed by the **Forty-Eighth Supplemental Indenture dated October 1, 2013**, filed with the SEC, which explicitly incorporates the **Original Indenture dated January 1, 1941**, as a governing instrument. This contract remains active and encumbers the physical assets of the company.

#### 3. FORMAL DEMANDS

- **TO BNY MELLON:** I demand a **Forensic Audit** of the Sinking Fund and Bond Ledgers for the 1941 Indenture. Your previous claim of "no records" is refuted by the 2013 Supplemental Indenture cited above.
- **TO ESSENTIAL UTILITIES:** I demand that this senior lien be satisfied or converted into **dividend-paying equity** in the merged entity before the close of the \$63B transaction.
- **TO THE PA PUC:** I request that the Commission stay the approval of **Docket A-2025-3058927** until this secured creditor claim is resolved to prevent a cloud on the title of Pennsylvania utility assets.
- **TO THE SEC:** I am reporting a potential **material omission** in the merger's financial disclosures (Form S-4/10-K) regarding these outstanding senior mortgage liabilities.



As the legitimate holder of 52 physical Mortgage Gold Bonds (Rutherford Heights Water Supply Co., 1911), I am formally submitting this proposal for a fair and transparent resolution regarding the unresolved secured debt currently encumbering the assets of Aqua Pennsylvania, Inc.

**1. Demand for Formal Debt Validation and Forensic Audit**

Under the 1941 Master Indenture and the recent **Sixty-Third Supplemental Indenture dated May 1, 2025**, Aqua Pennsylvania, Inc. continues to operate under a debt structure that inherits legacy liabilities. I request that the Commission order a **Forensic Audit of the Sinking Fund** to validate the contractual integrity of these 1911 bonds. This is a critical matter of transparency, especially following the written acknowledgment from the Trustee (BNY Mellon) on February 2, 2026, regarding potential record discrepancies.

**2. Proposal for Equitable Transaction (Debt-to-Equity Conversion)**

My objective is not to cause financial hardship to the utility or to place an undue burden on Pennsylvania consumers. I am proposing a **Fair Transaction** to resolve this material liability:

- **Conversion to Capital:** I am prepared to negotiate the exchange of the validated debt for **Preferred Shares with Voting Rights** in the newly merged entity.
- **Benefits to the Public Interest:** This conversion ensures the legal satisfaction of the 1911 mortgage liens without depleting the utility's cash reserves, thereby protecting the financial stability of the company and the interests of the ratepayers.

**3. Conclusion**




My name is **Luis Francisco**, and I am appearing today to respond to your **Provisional Order of April 14, 2026**.


I am handing to the Court today my '**Evidence Package**', which includes:




