Dear Mr. Homsher and Commission Members,

I am writing on behalf of Tricont Trucking Company (Utility Code 706302; Docket No: A-00119980) regarding your recent Tentative Order to cancel our Certificate of Public Convenience (CPC) for failure to operate continuously and without unreasonable interruption of service under 66 Pa.C.S. § 1501; 52 Pa. Code §§ 29.61-62, based on our reporting of zero revenue for 2024 and 2025.

Tricont Trucking Company had positive revenue and continuous operations in both 2024 and 2025. Its reported revenue was \$2,536,682.00 in 2024 and \$4,680,657.00 in 2025. (See Attachments A and B.) Those amounts were reported as exempt — as "transportation of your own property" — because Tricont is a wholly owned subsidiary of Del Monte Fresh Produce Company and transported only products owned by Del Monte Fresh Produce or its wholly owned affiliates, including movements to and from Del Monte's facilities in Eddystone, Pennsylvania and Gloucester City, New Jersey, and to local customers.


Tricont maintained regular, daily operations continuously throughout 2024 and 2025, transporting products solely within the Del Monte Fresh Produce corporate structure. Accordingly, Tricont did not cease operations and did not fail to operate continuously or without unreasonable interruption of service during the period identified in the Tentative Order.

Pennsylvania remains a critical part of Del Monte Fresh Produce's operations, and Tricont's continued daily transportation of products throughout the Commonwealth is essential to those operations.

For these reasons, Tricont respectfully requests that the Commission withdraw the Tentative Order, refrain from canceling its Certificate of Public Convenience, and refrain from suspending its vehicle registration. If you believe our filings have incorrectly classified our operations or revenue as exempt, please notify us promptly so we can review the classification and, if appropriate, amend or correct the relevant filings.

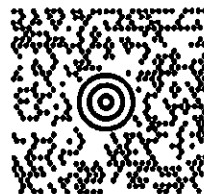
