I am writing to formally comment on the Tentative Order entered on April 16, 2026, regarding the proposed cancellation of Certificates of Public Convenience for failure to report positive operating revenue.

I respectfully request that the Commission **not cancel** the Certificate of Public Convenience held by **All-Terrain Excavation LLC**

The failure to file the required report detailing gross intrastate operating revenue by the March 31 deadline was unintentional. An administrative error had us send in the filing on the last day causing it to arrive later than the deadline. Our reported revenue was \$0.

We are committed to maintaining continuous service and ensuring all future reporting requirements under 66 Pa.C.S. § 510(b) are met in a timely manner.

Our operations provide an essential service to the community, and the cancellation would cause significant hardship to our business and the customers we serve. We remain ready and willing to comply with all Commission regulations and the Public Utility Code as also evidenced by our recent audit and letter of good standing with the PUC.
