Please accept these written comments on behalf of Wynn Transit in response to the Tentative Order entered at Docket No. M-2026-3061112 regarding the proposed cancellation of the company's Certificate of Public Convenience ("CPC").

Wynn Transit respectfully requests that the Commission not cancel its operating authority. The company's reporting of zero gross intrastate operating revenue for the referenced reporting periods was the result of temporary operational suspensions during the two missed years. These interruptions were temporary business circumstances and were not intended to reflect abandonment, discontinuance, or surrender of the company's Pennsylvania operating authority.

Wynn Transit fully intends to continue operating under its CPC and to maintain compliance with all applicable Pennsylvania Public Utility Commission requirements. The company remains committed to providing transportation services within the Commonwealth and anticipates resuming and expanding intrastate operations as business conditions continue to improve.

Cancellation of the company's CPC would impose a significant hardship on the business and would negatively affect its ability to lawfully provide transportation services in Pennsylvania moving forward.

For these reasons, Wynn Transit respectfully requests that the Commission withdraw the tentative determination to cancel the company's Certificate of Public Convenience and allow the company to retain its operating authority.
